

**APPLICATION FOR STAR MILL PARK SHELTER HOUSE**

Racine Village Star Mill Park facilities will be made available to and for the use of the general public.

A "USER FEE" will be charged for the use of the shelter houses, by private persons or groups. This is according to the adopted "USER FEE" schedule.

Applications for the use of the shelter houses are to be made in writing on an application issued by the Village of Racine.

**SHELTER HOUSE RESERVATIONS ARE NOT OFFICIALLY BOOKED UNTIL APPLICATION AND APPROPRIATE FEE IS RECEIVED. (Resolution #338; 8-3-87)**

Groups using the facilities must agree to abide by the following:

1. Group is to be responsible for any and all damages sustained to the property during its use; (The park is inspected before and after each use).
2. Group will be responsible for the cleaning and restoring of the facility to the same or to a better condition than when rented.
  - A. User fee does not include janitorial service.
  - B. Failure to clean up the area could result in denial of future use.
3. Group is responsible for providing the orderly conduct and behavior of the members of the group or other persons that come to the property.
4. The "user" agrees to indemnify and hold harmless the Village of Racine, its agents and employees; for all liability, claims, demands, or costs for or arising out of the use of the Star Mill Park by the "user" whether it is caused by the negligence of the "user" or the Village of Racine or either party's agents or employees, or otherwise. Racine Village and Star Mill Park Board and members cannot be held liable for injuries or accidents on village property.
5. Alcohol and/or illicit drugs are prohibited.
6. No pets are allowed.
7. Reservation "USER FEE" is for the one shelter house only
